

Neepawa-Gladstone Co-op Win Free Fuel for a Year 2023 Official Rules

The “Neepawa-Gladstone Co-op Win Free Fuel for a Year 2023” giveaway (the “Giveaway”) is offered by Neepawa-Gladstone Co-op Ltd. (“Giveaway Sponsor”) and is being promoted at the Giveaway Sponsor’s participating member retail co-operatives’ Neepawa-Gladstone Co-op Ltd. Gas Bars, Food Stores, Home Centers and Administration Office in Neepawa, Manitoba (“Participating Retail Co-ops”). The Giveaway is administered by Neepawa-Gladstone Co-op Ltd.

NO PURCHASE NECESSARY TO ENTER.

GENERAL GIVEAWAY INFORMATION: The Giveaway will be held at four (4) Participating Retail Co-op locations. You can enter into the drawing for a chance to win one (1) prize of Free Fuel for a Year grand prize, as described in Rule 3 below. You can obtain a free entry without making a purchase also as described in Rule 3 below. - 1) GIVEAWAY DATES:** The Giveaway begins at 12:01 AM CST on January 1, 2023 and is scheduled to end on February 28, 2023 at 11:59 PM CST (the “scheduled Giveaway End Date”). The period between the Giveaway Start Date and the scheduled Giveaway End Date is known as the “Giveaway Period”.
- 2) WHO CAN ENTER:** The Giveaway is open to all legal residents of Manitoba who have reached the age of majority in their Province of residence as of Giveaway Start Date and have a valid credit account with Neepawa-Gladstone Co-op Ltd. that was approved during the Giveaway Period. Employees and Board of Directors of Neepawa-Gladstone Co-op Ltd. are not eligible to enter to win prizes in the Giveaway.
- 3) HOW TO ENTER:** You will automatically be entered upon approval of cardlock credit application within the Giveaway Period.
 - a. NO PURCHASE ENTRY:** Throughout the Giveaway Period, you can request an entry for Free Fuel for a Year grand prizes, where no purchase is necessary (“No Purchase Necessary Entry”). You can obtain one entry by clearly printing your name, complete residential address, phone number, and valid e-mail address on a 3”x5” card. Mail in an envelope with proper postage to Neepawa-Gladstone Co-op c/o Free Fuel for a Year, Box 879, Neepawa, MB, R0J 1H0. There is a limit of one (1) No Purchase Necessary Entries per request per person. No mechanically reproduced or computer-generated requests allowed. All No Purchase Necessary Entry requests must be received by February 28, 2023 at 11:59 PM CST. You will only be contacted in the event that you are a winner. All entries become the property of Giveaway Sponsor and will not be returned. Giveaway Sponsor is not responsible for any lost, late, damaged, incomplete, illegible, misdirected, undeliverable or postage due mail; mail, network,

electronic, software, equipment, service, processing, accessibility or other errors, failures or issues; unauthorized access, tampering, hacking, theft or destruction; or other technical or human error related to the promotion, execution or administration of the Giveaway.

- 4) PRIZE:** There will be a total of one (1) draw held for the grand prize. The grand prize consists of \$2000 worth of fuel with the conditions of:
- a. Winner must have a valid cardlock credit account with Neepawa-Gladstone Co-op Ltd.
 - b. Cardlock credit account must have originated and been approved within the Giveaway Period.
 - c. The prize amount will be administered as twelve (12) consecutive monthly credits of \$166.66 applied to the winners' credit account.
 - d. Credit will only be applied to fuel purchased from Neepawa-Gladstone Co-op Ltd. Cardlocks.

The draw will be random and held at the Neepawa-Gladstone Co-op Ltd. Administration Office and the draw will include all the qualifying entries received during the Giveaway Period.

- 5) NOTIFICATION AND REDEMPTION:** If you have been selected as the potential winner of the draw described above, the Giveaway Sponsor will notify you via phone. If the selected winner does not respond to the Giveaway Sponsor's notification within five (5) days of the Prize Draw and the Giveaway Sponsor has made three (3) separate contact attempts, the potential winner will be disqualified, and a new potential winner may be drawn from among the eligible entries. As a condition of awarding any prize, winner must have signed and returned, within seven (7) days of receipt, the giveaway sponsor's Statement of Compliance, Release, and Indemnity Agreement under which, among other matters, winner confirms his/her compliance and eligibility with these Official Rules, completes, releases and indemnifies Giveaway Entities, and other certain parties.
